PRESIDENT'S REPORT

May was one of SAWMA's busiest and most successful months. For our education night we invited the South Australian Orthopaedic Nurses Association (SAON) to join us once again, for a combined meeting. The evening was well attended and the theme was osteomyelitis, diagnosis and management. The program provided a guide to patient and wound assessment, diagnostic tests and surgical, systemic and local wound management.

A few days later, SAWMA ran the Conference "Bacteria, Bioburden and Beyond". Interstate speakers included Greg Duncan, Michael Stacey, Keryln Carville and Annabelle Duncan. Local speakers included Tal Ellis, Oliver Mayo, Alison Cowin and David Cherry.

Here are a few of the many highlights of the conference.

- Hugh Hamilton looked at the role of bacteria in the winemaking process and kept delegates amused with his comparison of wine to a 'makeover'.
- Michael Stacey proposed a new way to think about 'critical colonisation' and the possible negative influence bacteria might have on wound healing throughout the colonisation continuum.
- Mellick Chehade shared his exciting work on a classification system for surgical debridement.
- Sue Templeton and Melissa O'Brien presented work their organisations have undertaken to manage topical antimicrobials.

The workshops were well attended and created much debate and discussion. It is hoped some of the work undertaken during the workshops might lead to guidelines to assist clinicians with issues including: storage of dressing products, and diagnosis and management of chronic wound infection. There was plenty of new knowledge to be had and valuable opportunities to network, meet colleagues, and peruse the trade displays.

Conference evaluations were excellent, and I would like to take this opportunity to thank: all the delegates whose attendance made this a successful event; the speakers, for their time and commitment; the committee for their hard work and preparation; and, the trade for their wonderful support. SAWMA is hoping to have most of the speaker presentations available on our website, within the next few months.

The August education night has evolved from ideas suggested in the conference evaluations. The key educational themes will be on wound product updates, wound debridement, wound cleansing and management of hypergranulation. The evening will commence with an update on products and then we will break into three workstations which will cover the remaining topics. I'm certain you will find it an excellent foundation to increase your knowledge and skills and promote best practice.

SAWMA looks forward to seeing you at our future educational events.

REPORT ON A VISIT TO THE WOUND HEALING RESEARCH UNIT – WALES, UK

The Wound Healing Research Unit (WHRU) at Cardiff University is an internationally recognised centre of excellence for the investigation of non-healing or complex wounds. Founded in 1991, this inaugural wound healing research unit is committed to the development of resources to benefit healthcare professionals and clients with wound healing problems. Within the unit are distinct areas of expertise in research, education and clinical practice. Professor Keith Harding is the Director of the WHRU.

With a planned trip to visit family in the UK, I couldn't resist the opportunity to visit this dynamic centre. The unit attracts many visitors from the local and international healthcare industry each year, therefore, careful planning is necessary to ensure individual learning needs are met. With my visit limited to only one day I was particularly interested in the benefits of a multi-disciplinary wound clinic and the implementation of holistic wound assessment.

The day was spent at the Diabetic Foot Clinic at the Royal Gwent Hospital and the St. Woolis Hospital, Newport. Unfortunately, Professor Harding was overseas, but the research team, consisting of a medical registrar, specialist nurses, podiatrists, orthotist, occupational therapist and a physiotherapist included me in their clinical assessment and management of patients presenting to the clinic. On a monthly basis, a vascular surgeon and orthopaedic surgeon join the team. It was clearly obvious the patient was the most important member of the team.

This dynamic and passionate group of professionals worked together to conduct a holistic patient assessment. The registrar and nurse reviewed all factors affecting healing, with particular interest in pain, nutrition, sleep patterns and a complete social history. There was no delay in initiating investigations (including tissue biopsy) to establish wound aetiology or in commencement of required drug therapy and wound bed preparation. The clinic was literally a 'one-stop shop' in which the patient avoided multiple appointments to different specialists.

I was overwhelmed at the genuine concern for the spiritual well-being and quality of life of each patient by the research team. This aspect was an integral part of the assessment and management plan, often resulting in assessment and modification of home/social circumstances by the occupational therapist and social worker. A truly holistic assessment.

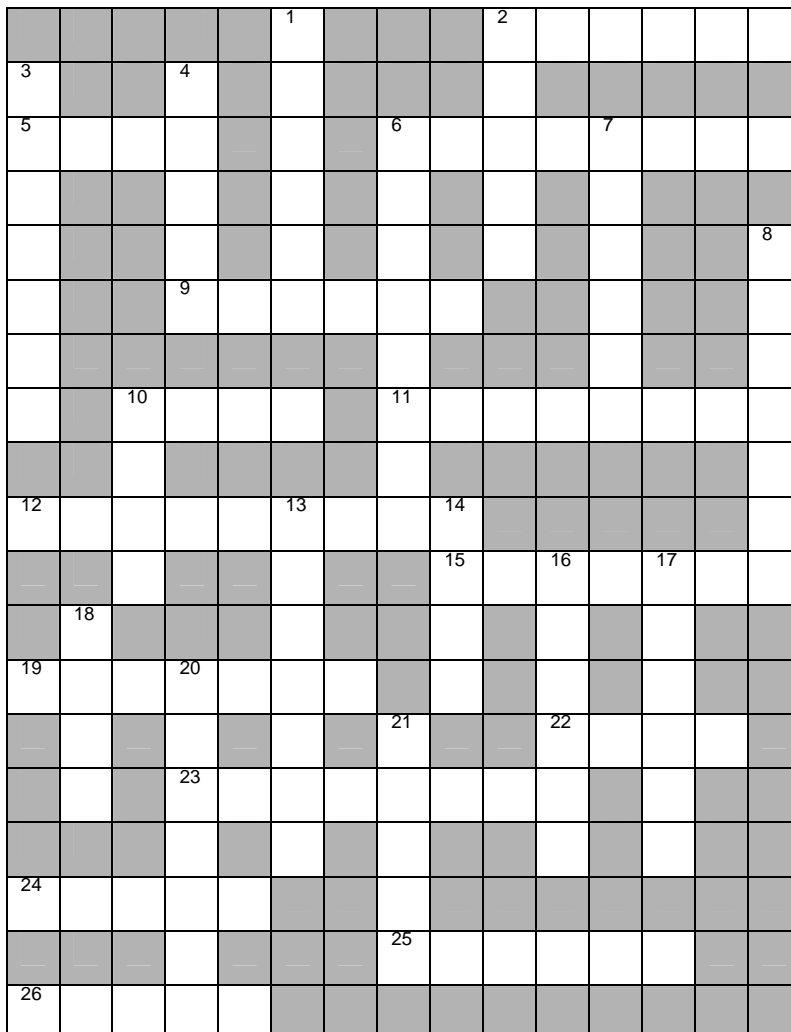
Excellent communication was provided to the community nurses and GPs regarding wound aetiology, factors affecting healing, investigations conducted and therapies commenced, together with a rationalised wound management plan.

My only disappointment was not being able to stay longer and attend more clinics to broaden my knowledge. The clear take-home message for me was that there is much investigating and assessing to be done before you decide on an appropriate wound management plan for your patient. A multi-disciplinary wound clinic promotes holistic assessment, prompt and appropriate investigations and management of the spiritual and physical well-being of a person with a wound.

I was certainly educated and inspired by this experience and urge all SAWMA members to consider a visit to the WHRU if undertaking a study tour or visiting the UK. The WHRU education department can be contacted via <http://www.whru.co.uk/cnt/eduh.asp> .

Wound Awareness Week 26-30 March 2007

This was an exciting initiative and included a national television community service announcement sponsored by the Pharmacy Guild, Smith & Nephew and Shear Comfort.

A number of community members responded to the WAW website page and provided an insight into community needs. The State and Territory activities, despite the short time frame, were excellent. 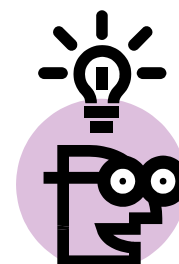

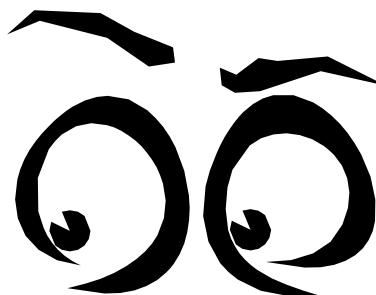
